We offer residents choices in how to fund their lifestyle. We've developed three payment options to match the individual needs of our customers, with key differences in when and how they pay their management fee.



Our discounted management fee option

Ideal for those who prefer to plan ahead, this payment option allows residents to settle their management fee upfront at a discounted rate when they move in. They can enjoy peace of mind that the management fee is taken care of before they leave.



Our deferred management fee option

For those looking for a seamless transition to retirement living, this payment option enables residents to defer their management fee until they leave. They simply make their entry payment, move in and enjoy, with funds in the bank to do the things they love. They can enjoy life to the fullest now, knowing their management fee will be settled later.



Bond — Our no management fee option

Perfect for those with the funds to move now, this payment option affords residents the benefit of not paying a management fee, by paying a refundable premium entry payment, along with a 3% establishment fee (non-refundable) when moving in. They'll feel safe in the knowledge that their premium entry payment will be returned upon leaving their community.






